I have agreed to volunteer my services to the Baltimore County Department of Recreation and Parks and the Lake Roland Nature Council. In consideration of the Baltimore County Department of Recreation and Parks and the Lake Roland Nature Council accepting me as a volunteer, I represent and agree to the following:

A. GENERAL PROVISIONS

1. I will attend any required orientation meeting(s) and will complete any required training program(s) for my Volunteer position.
2. I am not an employee of the Baltimore County Department of Recreation and Parks, Baltimore County or the Lake Roland Nature Council and I will not receive compensation for my services.
3. Volunteers/Non-Baltimore County employees are prohibited from operating power equipment owned by Baltimore County or the Baltimore County Department of Recreation and Parks.
4. Only after successfully completing equipment specific training and receiving written confirmation of such successful completion, am I authorized to operate that specific pieces of equipment. For example, chainsaw operation would require chainsaw training.
5. I must operate within the scope of duties for my Volunteer position, shall abide by all the rules and regulations of the Baltimore County Department of Recreation and Parks and the Lake Roland Nature Council, and shall abide by all directions and instructions given by its personnel.
6. As a representative of the Nature Council I will do my best to be courteous and helpful to those I encounter in the Lake Roland during my Volunteer activities.
7. I will review any handbooks or other written materials provided by the Baltimore County Department of Recreation and Parks and the Lake Roland Nature Council relating to my Volunteer facility and position.
8. I am not authorized to enforce the rules and regulations of Baltimore County.
9. Transportation to and from any Baltimore County property, facility or event is my own responsibility. While in route to or from such property, facility or event I am acting on my own and am not acting on behalf of the Baltimore County Department of Recreation and Parks and the Lake Roland Nature Council, its officers, Directors, Commissioners, employees or agents.

B. LIABILITY WAIVER

The undersigned, for myself and my heirs and executors, successors, and assigns, hereby releases and discharges the Baltimore County Department of Recreation and Parks and the Lake Roland Nature Council, its officers, Directors, Commissioners, employees or agents., and servants of and from any and all claims, demands and causes of action whatsoever nature which I or my heirs and executors, successors, and assigns ever may have against any of them for, on account of, by reason of, or arising in connection with the aforesaid Volunteer Program and my services as a Volunteer therein and hereby waive any and all such claims, demands and causes of action.
